



**The Honourable Stephen Conroy
– President**

Retirement from Parliament Senator, The Honourable, Stephen Conroy announced his resignation from Parliament in a speech tabled on 15 September 2016, to take effect 30 September. After 20 years of distinguished service, including in a number of Ministerial roles, Stephen drew his time in parliament to a close.

History in Parliament

With the previous Labor Government, Stephen was appointed Minister for Broadband, Communications and the Digital Economy and Minister Assisting the Prime Minister for Digital Productivity in September 2010. He was also Leader of the Government in the Senate during this time.

Stephen was appointed as a Senator for Victoria for the Australian Labor Party in 1996. Previously he was an industrial officer and superannuation officer for the Transport Workers Union Victorian Branch from 1992 to 1996, a ministerial adviser to Victoria's Minister for Industry from 1990 to 1992 and an assistant adviser to the Speaker of the House of Representatives from 1988 to 1990.

In late 2016, Stephen was appointed CEO of an industry association for Australian and international companies, utilising his considerable experience with all levels of government.

Stephen and his wife live in Melbourne with their daughter. Also, a sports nut, Stephen was a national volleyball representative as a teenager.

Stephen was elected to the Board in 2005 and shortly after was elected President. He has provided 10 years continuous Board service in this time.
